Department of Planning requires that a community engagement strategy is developed to guide consultation with the community on all CHRMAP processes, including that being conducted by CGG. NACC will be providing comment on this document.

7 Pt Moore beach closure to ORVs

Mark R suggested the Geraldton Coastcare Group apply for Coastwest funding for ORV closures at Point Moore.

Suggestion prompted discussion on whether this is a project the Geraldton Coastcare Group applies for or the established groups in that area (Friends of Point Moore).

Wendy P suggested the grant should incorporate more than just one site to close beach access to ORV's in Geraldton if the group is to apply for the grant.

Mike D said there would need to be studies done before ORV closures on beaches at places such as Point Moore as they are multi-purpose zones. Additional car parking spaces would need to be made available for high-use areas if beaches are closed.
